**JOB DESCRIPTION – SUPPORT WORKER**  
**Scunthorpe Learning Disabilities Service**



**Hours:** Full and part time hours, to be worked flexibly to include evenings, weekends and sleep-ins according to the needs of the service.

**Responsible to:** Senior support worker/ Service Manager

**The Role:**

Supported Living service in Scunthorpe for 1 individual. You will be supporting individuals with a learning disability and other support needs.

We are seeking to recruit staff who are confident, flexible, calm, patient, motivating, enthusiastic and consistent. You will provide person centred support to a service user who have a range of disabilities; you will support individuals to live a valued life within their local community and achieve positive outcomes.

You will work as part of a team with some lone working across a flexible rota system including sleep ins. Drivers preferred as the individual has a mobility vehicle.

**Main Duties**

1. To develop and sustain warm and trusting relationships with the service user.
2. To promote the self-esteem, happiness and emotional health of the service user.
3. To offer unconditional positive regard to the service uses, to respect right to privacy and to ensure that their dignity is maintained at all times.
4. To encourage and support the service user to express their needs, views and concerns. To enable the service user to make choices and decisions and to participate as fully as possible in planning and decision-making processes. To enable the service user to contribute actively to decisions regarding their own care, support and activities through verbal and non-verbal communication methods which are tailored to their individual needs (e.g. Makaton, BFL, PECS)
5. To respect and promote the rights and entitlements of people with learning disabilities and to enable them to participate as fully as possible in their communities and to maintain community connections.
6. To carry out the role of key worker and to enable the service user to achieve their goals and dreams by working alongside them to develop and implement within their person centred plans. To be responsive to changing needs and preferences.
7. To support the service user in maintaining the safety, security, cleanliness and comfort of their home. To support the service user in understanding and adhering to the terms and conditions of their tenancy agreement and in enjoying the rights and responsibilities of being a tenant.
8. To provide respectful personal care in accordance with the needs, wishes and preferred routines outlined in the individual's personal support plans.
9. To follow agreed guidelines for the provision of support and assistance to individuals with mobility needs. To use aids, lifting equipments (e.g. hoists), monitoring alarms and other assistive technologies in accordance to the guidelines.

**10.** To enable service users to become as independent as possible and to grow in confidence, competence and personal effectiveness in the following areas:

- Social skills/relationships
- Personal care & hygiene
- Daily living skills
- Managing money
- Using community resources and facilities
- Social, leisure and work activities
- Self organisation and coping abilities
- Personal safety

To achieve this by providing assistance, support, advice, teaching, role modelling and by motivating, encouraging and offering positive feedback. To always seek to actively involve the service user in everyday tasks and activities.

- 11.** To support the service user in claiming their full benefit entitlement, budgeting and managing their personal finances as independently as possible to support their chosen lifestyle.
- 12.** To support the service user to enjoy a wide range of activities within the home and community which meets their needs. To support service users in developing a socially valued lifestyle which includes a varied range of culturally and age appropriate experiences, building on their strengths, interests and aspirations. To enable them to access social, leisure, work and educational opportunities.
- 13.** To ensure that the service user receive all necessary advice, care and regular health checks to ensure their physical health and well being. To promote nutrition, relaxation, exercise and a healthy lifestyle. To observe and monitor the service users' emotional and physical well being and to inform the Registered Manager, families and other agencies of any concerns or significant changes in their needs, behaviour and circumstances.
- 14.** To offer positive behaviour support to individuals who express their frustrations and needs through challenging behaviour by using appropriate strategies, management protocols and guidelines agreed with the multi-disciplinary team.
- 15.** To work closely with the family of the service user and other professionals involved in their care and support to provide coordinated services to meet the needs of the individuals. To encourage and support connections with families and friends. To positively and respectfully communicate with family and other professionals at all times.
- 16.** To follow the guidance and risk management strategies outlined in the individual's risk management plan. To work in a safe and responsible manner to safeguard vulnerable service users from harm whilst ensuring they are able to make choices, enjoy new experiences and live a full life.
- 17.** To ensure that vulnerable adults and children are safeguarded from harm. To comply with Creative Support and Council's safeguarding policy and procedures and to report any concerns regarding vulnerable adults or children with immediate effect to the Council, the Registered Manager and the Duty/On Call Manager.
- 18.** To assist the service user in the administration and monitoring of prescribed medication in accordance with the Scheme's Medication Policy. To carefully follow instructions for prescribed medication and to ensure that all medication is recorded in accordance to with agency policies.

<b>Please Note:</b> <i>Our pay date is the 15th of each month (or the Friday before if this falls on a Saturday or Sunday). You will be paid in arrears for the previous 4/5 weeks, dependent on your starting date within the month. Starting pay points are allocated upon commencing the role based on criteria inclusive of experience, current specialism, salary and qualifications.</i>		

#### Sleep-Ins:

Support Workers may be required to undertake sleep-ins. Where sleep-ins are undertaken by Support Workers/Supported Living Workers these are paid additionally per sleep-in, over and above the salary for the employee's contracted hours on the basis of the relevant National Minimum Wage (NMW) or National Living Wage (NLW).

#### Hours of Work:

Full or part time hours will be considered for all roles. Full time hours are 37.5 per week, part time to be agreed subject to a minimum of 15 hours per week. To be worked flexibly on a rota which will include evenings, weekends and public holidays according to the needs of the service.

#### Holidays:

20 days plus 8 statutory days (pro rata) for part-time.

#### Part Time Work:

Please note that annual leave and other entitlements are calculated on a pro-rata basis for employees working less than 37.5 hours. We take a positive view of part-time work and will consider reasonable requests for part time hours for a minimum of 15 hours per week.

#### Bank Holidays:

An enhancement is paid for working at Christmas and New Year. We do not pay enhancements for working evenings, weekends or any other public holiday.

#### Level 2 and/or Level 3 Health & Social Care Diploma:

All employees will be required to undertake and complete the Level 2 and/or Level 3 Health and Social Care Diploma, as a condition of their employment if you already hold NVQ 2 health and social care or equivalent qualification you will not need to do the award again, but we may support you to undertake a level 3 or other relevant qualification at our cost.

#### Birthday Holiday Bonus:

After two years of continuous service you will be permanently entitled to one additional day (pro rata for part time employees) annual leave to be taken two weeks either side of your birth date. If you do not take this additional day within that period you will lose this entitlement for that year. This bonus will only come into effect in the leave year after two full years' service. Staff who are on maternity, paternity, adoption and sick leave at the time of their birthday will be entitled to take this additional leave upon their return to work.

### Disclosure Checks:

All appointments will be subject to DBS enhanced disclosure and ISA checks.

### Probationary Period:

The first four months will constitute a probationary period. When this is successfully completed, employment will be confirmed.

### Probationary Bonus:

After the probationary period has been satisfactorily completed your further employment will be confirmed. Upon successful completion of your probationary period you will be entitled to a one off £100 bonus pro rata (subject to tax), providing all induction processes have been completed satisfactorily and upon completion and submission of you end of probationary review paperwork.

### Sickness Policy:

Creative Support operates a discretionary company sick pay benefit scheme which is for the purposes of preventing hardship during times of serious illness. The eligibility criteria and conditions for payment of Company Sick Pay (inclusive of SSP) are shown in the Employee Handbook. You may be eligible for Company Sick Pay benefits subject to compliance with these criteria as follows:-

- Creative Support do not pay for the first three days of **any** sickness absence.
- First twelve months service - Not eligible for Company Sick Pay though you may be entitled to SSP.
- Twelve months to eighteen months service - Up to a maximum of four weeks at full pay.
- Twenty four months plus service - Up to a maximum of eight weeks at full pay followed by four weeks at half pay.

### Pension:

Creative Support operates an auto-enrolment pension scheme with the People's Pension.

### Life Assurance:

Currently set at two time's basic annual salary. Staff become members of a non-contributory group life assurance scheme after 6 month employment. This scheme provides a death in service benefit of two time's annual salary. Participation in this scheme is subject to the rules of the scheme as amended from time to time. We reserve the right to discontinue, vary or amend its life assurance scheme at any time on reasonable notice to you.

### Discretionary Benefits:

Creative Support offers discretionary benefits in addition to statutory benefits. These include:
