#### JOB DESCRIPTION - SUPPORT WORKER

### Oaklea House, Barrow-in-Furness



Hours: Full time or part time. (Flexible: to include evenings, weekend and public

holidays according to the needs of the service).

Responsible to: Senior Support Worker and senior colleagues

#### The Role:

To provide individualised person-centred support for service users at Oaklea House, Barrow-in-Furness. To enable users of the service to enjoy a fulfilled and valued life, including having options to be involved in a variety of meaningful activities. To ensure that individuals are able to participate in the community which they are a part of and develop their abilities as fully as possible.

#### **Main Duties:**

- 1. To develop and sustain warm and trusting relationships with service users.
- **2.** To promote the self-esteem, happiness and emotional health of service users.
- 3. To respect the client's right to privacy and to ensure that their dignity is maintained at all times.
- **4.** To encourage and support service users in expressing their needs, views and concerns. To enable service users to make choices and decisions and to participate as fully as possible in planning and decision-making processes.
- **5.** To respect and promote the rights and entitlements of people with learning disabilities who may require positive behavioural support, and to enable them to participate as fully as possible in their communities.
- **6.** To support service users in maintaining the safety, security and comfort of their homes.
- **7.** To support service users in understanding and adhering to the terms and conditions of their tenancy agreement and in enjoying the rights and responsibilities of being a tenant.
- **8.** To be responsive to the individual needs of service users within the framework of their Person Centred Plans and to respond flexibly to changing needs.
- **9.** To enable service users to become as independent as possible and to grow in confidence, competence and personal effectiveness in the following areas:
  - Social skills/relationships
  - Personal care & hygiene
  - Daily living skills
  - Using community resources and facilities
  - Social, leisure and work activities
  - Self-organisation and coping abilities
  - Personal safety

To achieve this through the provision of practical assistance, support, therapeutic recreation and education sessions, teaching, advice, role modelling, encouragement and positive feedback.

- **10.** To support people who express their frustrations and needs through challenging behaviour by using appropriate strategies and intervention frameworks as specified by the Person Centred Plan.
- **11.** To work within agreed management protocols and guidelines for individuals with complex needs.
- **12.** To ensure that service users receive all necessary advice, care and regular health checks to ensure their physical health and well being. To promote nutrition, relaxation, exercise and a healthy lifestyle.
- **13.** To support service users in claiming their full benefit entitlement, budgeting and managing their personal finances.
- **14.** To support service users in developing a socially valued lifestyle which includes a varied range of culturally and age appropriate experiences, building on the strengths, interests and aspirations of the service user. To enable people to access social, leisure, work and educational opportunities.
- **15.** To enable service users to access developmental opportunities, new experiences and challenges, whilst not being exposed to unacceptable risks.
- **16.** To assist service users in the administration and monitoring of prescribed medication in accordance with the Scheme's Medication Policy.
- **17.** To observe and monitor the service users' emotional and physical well being and to inform relevant staff and agencies of any concerns or significant changes in their needs, behaviour and circumstances.
- **18.** To take appropriate action in the event of unforeseen emergencies, ensuring that the Unit Business Manager and the Home Leader is informed promptly.
- **19.** To follow Health and Safety guidelines carefully and to alert the Project Manager immediately of any concerns in relation to Health and Safety issues.
- **20.** To contribute to project records and individual case files.
- **21.** To carry out and record all financial transactions involving service users within agency guidelines.
- **22.** To carry out general administrative duties, housing management tasks and services as required.
- **23.** To contribute to service users' reviews, through the provision of verbal and written reports and by attending Support Planning meetings.

- **24.** All employees should be aware that due to the nature of work Creative Support undertakes there is a requirement to support service users with daily living skills and individual activities which will include moving and handling and may involve supporting people with personal care needs.
- **25.** To provide respectful personal care in accordance with the needs, wishes and preferred routines outlined in the individual's personal support plans. Some individuals will require support with their physical/mobility disabilities and may require support in wheelchairs, using hoists and other appropriate equipment to meet personal needs.
- **26.** In accordance with the Health and Social Care Act 2008, to actively participate in the prevention and control of infection within the capacity of the role.

#### Other:

- 27. To notify Line Manager of planned whereabouts and to submit accurate timesheets weekly.
- 28. To provide regular verbal and written reports to colleagues.

- **30.** To carry out all work in a manner consistent with the aims of the project and the service principles adopted by Creative Support.

- **33.** To undertake specific specialised training identified to enhance on team expertise, of working with people with complex needs.

- **36.** To take on the role of shift co-ordinator when required.

**Please Note:** Our pay date is the 15th of each month (or the Friday before if this falls on a Saturday or Sunday). You will be paid in arrears for the previous 4/5 weeks, dependent on your starting date within the month. Starting pay points are allocated upon commencing the role based on criteria inclusive of experience, current specialism, salary and qualifications.

### **Holidays:**

20 days plus 8 statutory days pro rata.

### **Hours of Work:**

Full or part time. Full time is 37.5 hours per week, part time to be agreed subject to minimum 15 hours per week. To be worked flexibly on a rota which will include evenings, weekends and public holidays according to the needs of the service.

### **Bank Holidays:**

An enhancement is paid for working at Christmas and New Year. We do not pay enhancements for working evenings, weekends or any other public holiday.

### Care Certificate and Level 2/3 Health & Social Care Diploma:

All employees will be required to undertake and complete the Care Certificate. Following the successful completion of the probationary period staff are automatically enrolled onto Level 3 Health and Social Care Diploma. If you hold NVQ/Diploma 2/3 Health and social care or equivalent you will of course not need to do the award again, but we may support you to undertake qualifications.

### **Birthday Holiday Bonus:**

After two years of continuous service you will be permanently entitled to one additional day (pro rata for part time employees) annual leave to be taken two weeks either side of your birth date. If you do not take this additional day within that period you will lose this entitlement for that year. This bonus will only come into effect in the leave year after two full years' service. Staff who are on maternity, paternity, adoption and sick leave at the time of their birthday will be entitled to take this additional leave upon their return to work.

### **Disclosure Checks:**

All appointments will be subject to DBS enhanced disclosure and ISA checks.

#### **Probationary Period:**

The first four months will constitute a probationary period. When this is successfully completed, employment will be confirmed.

### **Probationary Bonus:**

After the probationary period has been satisfactorily completed your further employment will be confirmed. Upon successful completion of your probationary period you will be entitled to a one off £100 bonus pro rata (subject to tax), providing all induction processes have been completed satisfactorily and upon completion and submission of you end of probationary review paperwork.

### **Sickness Policy:**

Creative Support operates a discretionary company sick pay benefit scheme which is for the purposes of preventing hardship during times of serious illness. The eligibility criteria and conditions for payment of Company Sick Pay (inclusive of SSP) are shown in the Employee Handbook. You may be eligible for Company Sick Pay benefits subject to compliance with these criteria as follows:-

- Creative Support do not pay for the first three days of **any** sickness absence.
- First twelve months service Not eligible for Company Sick Pay though you may be entitled to SSP
- Twelve months to twenty four months service Up to a maximum of four weeks at full pay.
- Twenty four months plus service Up to a maximum of eight weeks at full pay followed by four weeks at half pay.

#### **Pension:**

Creative Support operates an auto-enrolment pension scheme with the People's Pension.

#### **Life Assurance:**

Currently set at two times basic annual salary. Staff become members of a non-contributory group life assurance scheme after 6 months of employment. This scheme provides a death in service benefit of two times annual salary. Participation in this scheme is subject to the rules of the scheme as amended from time to time. We reserve the right to discontinue, vary or amend the life assurance scheme at any time on reasonable notice to you.

### **Discretionary Benefits:**

Creative Support offers discretionary benefits in addition to statutory benefits. These include:

- Paid paternity leave
- Enhanced maternity leave
- Compassionate leave
- Carer's leave up to 5 days per annum

#### **Employee Assistance Service:**

This is currently administered by Health Assured. This is a completely free service, offering valuable advice on benefits, financial matters, consumer advice, health and legal issues. There is also a free counselling service which is accessible 24 hours a day, 7 days a week. Anything discussed with Health Assured is completely confidential and will not be shared with Creative Support.
