Hours: As required on a relief basis (i.e. on a non-contracted basis).

Responsible to: Manager and senior colleagues

The Role

To provide individualised person-centred support to service users with learning disabilities and complex health needs enable them to enjoy a fulfilling and valued life, to participate in the community and to develop their abilities as fully as possible.

Main Duties

- 1. To develop and sustain warm and trusting relationships with service users.
- 2. To promote the self-esteem, happiness and emotional health of service users.
- **3.** To respect the client's right to privacy and to ensure that their dignity is maintained at all times.
- **4.** To encourage and support service users in expressing their needs, views and concerns. To enable service users make choices and decisions and to participate as fully as possible in planning and decision-making processes.
- 5. To respect and promote the rights and entitlements of people with learning disabilities and mental health needs, and to enable them to participate as fully as possible in their communities.
- 6. To support service users in maintaining the safety, security and comfort of their homes.
- **7.** To support service users in understanding and adhering to the terms and conditions of their tenancy agreement and in enjoying the rights and responsibilities of being a tenant.
- **8.** To be responsive to the individual needs of service users within the framework of their Person Centred Plans and to respond flexibly to changing needs.
- **9.** To enable service users to become as independent as possible and to grow in confidence, competence and personal effectiveness in the following areas:
 - Social skills/relationships
 - Personal care & hygiene
 - Daily living skills
 - Using community resources and facilities
 - Social, leisure and work activities
 - Self organisation and coping abilities
 - Personal safety

- **10.** To support people who express their frustrations and needs through challenging behaviour by using appropriate strategies and intervention frameworks as specified by the Person Centred Plan.
- **11.** To work within agreed management protocols and guidelines for individuals with complex needs.
- **12.** To ensure that service users receive the necessary advice, care and regular health checks to ensure their physical health and well being. To promote nutrition, relaxation, exercise and a healthy lifestyle.
- **13.** To support service users in managing their personal finances.
- **14.** To support service users in developing a socially valued lifestyle which includes a varied range of culturally and age appropriate experiences, building on the strengths, interests and aspirations of the service user. To enable people to access social, leisure, work and educational opportunities.
- **15.** To enable service users to access developmental opportunities, new experiences and challenges, whilst not being exposed to unacceptable risks.
- **16.** To assist service users in the administration and monitoring of prescribed medication in accordance with the Scheme's Medication Policy.
- **17.** To observe and monitor the service users' emotional and physical well being and to inform relevant staff and agencies of any concerns or significant changes in their needs, behaviour and circumstances.
- **18.** To take appropriate action in the event of unforeseen emergencies, ensuring that the Scheme Senior Support Worker and Project Manager are informed promptly.
- **19.** To follow Health and Safety guidelines carefully and to alert the Project Manager immediately of any concerns in relation to Health and Safety issues.
- **20.** To contribute to project records and individual case files.

- **21.** To carry out and record all financial transactions involving service users within agency guidelines.
- **22.** To carry out general administrative duties, housing management tasks and services as required.

23. To contribute to service users' reviews, acting as Keyworker through the provision of verbal and written reports and by attending Support Planning meetings.

Other

- 24. To notify Line Manager of planned whereabouts and to submit accurate timesheets weekly.
- **25.** To provide regular verbal and written reports to colleagues.
- 26. To accept support, supervision and guidance from senior colleagues.
- **27.** To carry out the work in a manner consistent with the aims of the project and the service principles adopted by Creative Support.
- **28.** To comply with and to implement the Equal Opportunities Policy.
- **29.** To maintain confidentiality at all times, in accordance with the agreed policy.
- **30.** To undertake specific specialised training identified to enhance on team expertise, of working with people with learning disabilities and mental health needs.

Some individuals will require support with their physical/mobility disabilities and may require support in wheelchairs, using hoists and other appropriate equipment to meet personal needs.
- **37.** To work flexibly and responsively to meet the changing needs of the service.

Salary: £12.30 per hour plus rolled up holiday pay

Please Note: Our pay date is the 15th of each month (or the Friday before if this falls on a Saturday or Sunday). You will be paid in arrears for the previous 4/5 weeks, dependent on your starting date within the month. Starting pay points are allocated upon commencing the role based on criteria inclusive of experience, current specialism, salary and qualifications.

Hours of Work:

Zero hours contract, as and when required.

Holidays:

You will receive paid holiday hours in respect of holidays which have been accrued. Payments will be calculated as an average, using hours worked over the preceding 12 week period up to a maximum of 180 hours (24 days) per holiday year. Holiday pay is not automatically given and these must be requested.

Probationary Period:

The first four months will constitute a probationary period. When this is successfully completed, employment will be confirmed.

Sickness Policy: You will not be entitled to company sick pay.
