Hull Extra Care Service

- **Hours:** Full time or part time. (Flexible: to include evenings, weekend and public holidays according to the needs of the service).
- **Responsible to:** Registered Manager/Team leader/ Senior Extra Care Worker

The Role:

To provide person centred care and support to people of all ages in our extra care service in Hull. You will provide re-enablement to assist people to live as independent lives as possible in their own homes. You will engage with service users and build trusting therapeutic relationships. Your role will include providing care and support as part of a care planned approached. You will be expected to complete tasks, including personal care, to a high standard demonstrating dignity and respect for individuals at all times. You will be expected to work closely with other professionals, agencies and families/ carers and demonstrate positive customer care skills.

The Hull Extra Care Service is a busy, dynamic services in residential areas; the mixture of personal care, housing related support and activities provide a wide range of opportunities for staff to engage with residents on multiple levels. Individuals living within the services have low, medium and high care needs and access to a pull cord alarm service. Day to day care is a mixture of planned and responsive care and requires a mixture of high energy, patience and dedication to ensure residents have the best service provision. Training is provided.

Main Duties:

- **1.** To develop warm and trusting relationships with service users to encourage them to express their needs, views and concerns.
- **2.** To respect the service user's right to privacy and to ensure that their dignity is maintained at all times.
- **3.** To be flexible and responsive to the needs of service users as directed by their Individual Care Plans.
- **4.** Support service users to maintain and develop practical and social skills to retain optimum control over their lives.
- **5.** To provide personal care in a sensitive and dignified way and in accordance with the service users wishes.
- **6.** To advise and support service users in all aspects of managing their tenancy and maintaining the safety, hygiene and comfort of their home.
- **7.** To promote the service user's self esteem and enable them to express their preferences and make choices and decisions.
- **8.** To enhance the confidence and coping abilities of service users through encouragement and positive feedback.
- **9.** To assist service users with general activities of daily living including:

-Shopping -Meal Preparation

-Domestic tasks -Laundry and ironing -Managing day to day finances

- **10.** To advise, encourage and support service users so as to maximise their self care and independent living skills.
- **11.** Where required to support service users in budgeting and managing their finances and to ensure that they are able to maximise their income by liaising with Welfare Rights agencies.
- **12.** To support service users in meeting their cultural and spiritual needs and in expressing their personal identity.
- **13.** To encourage service users to identify their strengths and interests and to support service users in accessing social and leisure activities. To promote the personal development of service users through developing care plans which outline goals and aspirations for the future.
- **14.** To enable service users to participate in their local communities and to enjoy the rights and responsibilities of citizenship.
- **15.** To promote a healthy lifestyle and to give appropriate advice and support in respect of diet, exercise, stress reduction, smoking cessation and weight management.
- **16.** To inform the Manager/Team Leader, Care Manager and relevant agencies of any concerns or significant changes in their needs and circumstances. To report any concerns regarding children or vulnerable adults with immediate effect to the Manager/Team Leader or the Duty/On Call Manager.
- **17.** To support service users in complying with prescribed medication and self medication programmes. To liaise with the service user's GP/ Care Manager in respect of compliance with prescribed medication. To report all side effects related to medication.
- **18.** To work within agreed risk management guidelines and to assist service users in reducing risks to themselves or others. To promptly report all concerns regarding risks to senior staff, the Duty Manager/On Call Manager and relevant agencies.
- **19.** To maintain a high standard of customer care and to encourage feedback from service users and other agencies. To promptly report and document all complaints, suggestions and feedback.
- **20.** To take appropriate action in the event of emergencies, ensuring that the Service Manager/ Registered Manager and Team Leader or the Duty/On Call Manager is informed promptly.
- **21.** To follow Health and Safety guidelines carefully and to alert the Project Manager/Deputy Manager immediately of any concerns in relation to Health and Safety issues.
- **22.** To ensure that accurate records are kept in the prescribed format. To document all work undertaken in support of service users, their general progress, any concerns and any communication or liaison with other agencies.
- **23.** To ensure that all financial transactions relating to the project or service users are promptly and accurately recorded within the agreed guidelines.

- 24. To fulfil the role of Key Worker as required, under the direction of a senior member of staff.
- **25.** All employees should be aware that due to the nature of work Creative Support undertakes there is a requirement to support service users with daily living skills and individual activities which will include moving and handling and may involve supporting people with personal care needs.

- **26.** To notify your Line Manager of planned whereabouts and to submit accurate timesheets weekly.
- **27.** To accept regular support and supervision from your Line Manager.
- **28.** To carry out all work in a manner consistent with the aims of the project and the service principles adopted by Creative Support.
- **29.** To comply with Creative Support's Equal Opportunities Policy.
- **30.** To maintain confidentiality at all times, in accordance with the agreed policy.
- **31.** To identify training needs in discussion with your Line Manager and to attend training events and courses as required.

- 34. To provide respectful personal care in accordance with the needs, wishes and preferred routines outlined in the individual's personal support plans. - 35. In accordance with the Health and Social Care Act 2008, to actively participate in the prevention and control of infection within the capacity of the role.
- 36. Any other duties as required.

TERMS AND CONDITIONS – EXTRA CARE SUPPORT WORKER Hull Extra Care Service



Salary: £12.60 per hour

Please Note: Our pay date is the 15th of each month (or the Friday before if this falls on a Saturday or Sunday). You will be paid in arrears for the previous 4/5 weeks, dependent on your starting date within the month.

Hours of Work:

Full or part time hours will be considered for all roles. Full time hours are 37.5 per week, part time to be agreed subject to a minimum of 15 hours per week. To be worked flexibly on a rota which will include evenings, weekends and public holidays according to the needs of the service.

Holidays:

20 days plus 8 statutory days pro rata.

Part Time Work:

Please note that annual leave and other entitlements are calculated on a pro-rata basis for employees working less than 37.5 hours. We take a positive view of part-time work and will consider reasonable requests for part time hours for a minimum of 15 hours per week.

Bank Holidays:

An enhancement is paid for working at Christmas and New Year. We do not pay enhancements for working evenings, weekends or any other public holiday.

Level 2 and/or Level 3 Health & Social Care Diploma:

All employees will be required to undertake and complete the Level 2 and/or Level 3 Health and Social Care Diploma, as a condition of their employment if you already hold NVQ 2 health and social care or equivalent qualification you will not need to do the award again, but we may support you to undertake a level 3 or other relevant qualification at our cost.

Birthday Holiday Bonus:

All employees are entitled to one additional day (pro rata for part time employees) annual leave to be taken two weeks either side of your birth date. If you do not take this additional day within that period you will lose this entitlement for that year. Staff who are on maternity, paternity, adoption and sick leave at the time of their birthday will be entitled to take this additional leave upon their return to work.

Disclosure Checks:

All appointments will be subject to DBS enhanced disclosure and ISA checks.

Probationary Period:

The first four months will constitute a probationary period. When this is successfully completed, employment will be confirmed.

Probationary Bonus:

After the probationary period has been satisfactorily completed your further employment will be confirmed. Upon successful completion of your probationary period you will be entitled to a one off

£100 bonus pro rata (subject to tax), providing all induction processes have been completed satisfactorily and upon completion and submission of you end of probationary review paperwork.

Sickness Policy:

Creative Support operates a discretionary company sick pay benefit scheme which is for the purposes of preventing hardship during times of serious illness. The eligibility criteria and conditions for payment of Company Sick Pay (inclusive of SSP) are shown in the Employee Handbook. You may be eligible for Company Sick Pay benefits subject to compliance with these criteria as follows:-

- Creative Support do not pay for the first three days of **any** sickness absence.
- First twelve months service Not eligible for Company Sick Pay though you may be entitled to SSP.
- Twelve months to twenty four months service Up to a maximum of four weeks at full pay.
- Twenty four months plus service Up to a maximum of eight weeks at full pay followed by four weeks at half pay.

Pension:

Creative Support operates an auto-enrolment pension scheme with the People's Pension.

Life Assurance:

Currently set at two time's basic annual salary. Staff become members of a non-contributory group life assurance scheme after 6 month employment. This scheme provides a death in service benefit of two time's annual salary. Participation in this scheme is subject to the rules of the scheme as amended from time to time. We reserve the right to discontinue, vary or amend its life assurance scheme at any time on reasonable notice to you.

Discretionary Benefits:

Creative Support offers discretionary benefits in addition to statutory benefits. These include:

- Carer's leave up to 5 days per annum

Employee Assistance Service:

Your Rewards:
