JOB DESCRIPTION —SENIOR SUPPORT WORKER

Bolton Supported Living services for people with Learning Disabilities

Hours: 37.5 hours per week, to be worked flexibly to include evenings and

weekends, according to the needs of the service.

Responsible to: Registered Manager and Project Manager.

The Role:

To assist the Project Manager in the operational management of a high quality support service for people with learning disabilities, autistic spectrum conditions and other complex needs in the Bolton area. To provide outcome focused support which enables service users to lead fulfilling and valued lives, maintain their tenancies, participate in their local community, develop independent living skills and achieve their personal goals and desired outcomes.

Main Duties:

- **1.** To develop and sustain warm and trusting relationships with service users.
- **2.** To promote the self-esteem, happiness and emotional health of service users.
- **3.** To respect the person's right to privacy and to ensure that their dignity is maintained at all times.
- 4. To encourage and support service users in expressing their needs, views and concerns. To enable service users make choices and decisions and to participate as fully as possible in planning and decision-making processes.
- To respect and promote the rights and entitlements of people with learning disabilities, mental health needs and autistic spectrum disorders and to enable them to participate as fully as possible in their communities.
- 6. To be responsive to the individual needs of service users within the framework of their Person Centred Plans and to respond flexibly to changing needs. It is important to be creative when engaging service users to promote their quality of life and offer opportunities to promote their daily living skills and independence which are in accordance with local, agency and government guidance.
- 7. To enable service users to become as independent as possible and to grow in confidence, competence and personal effectiveness in the following areas:
 - Social skills/relationships
 - Personal care & hygiene
 - Daily living skills
 - Using community resources and facilities
 - Social, leisure and work activities
 - Self organisation and coping abilities
 - Personal safety

To achieve this through the provision of practical assistance, support, teaching, advice, role modelling, encouragement and positive feedback.

- **8.** To support people who express their frustrations and needs through challenging behaviour by using positive behaviour management strategy.
- **9.** Support service users to communicate effectively using their preferred forms of communication.

- **10.** To monitor, review and evaluate individual protocols for people with learning disabilities, mental health needs and autism in line with their Person Centred Plan.
- 11. To ensure that service users receive all necessary advice, care and regular health checks to ensure their physical health and well being. To promote nutrition, relaxation, exercise and a healthy lifestyle.
- 12. To support service users in developing a socially valued lifestyle which includes a varied range of culturally and age appropriate experiences, building on the strengths, interests and aspirations of the service user. To enable people to access social, leisure, work and educational opportunities.
- **13.** To enable service users to access developmental opportunities, new experiences and challenges, whilst not being exposed to unacceptable risks.
- **14.** To assist service users in the administration and monitoring of prescribed medication in accordance with the Service's Medication Policy.
- 15. To observe and monitor the service users' emotional and physical well being and to inform relevant staff and agencies of any concerns or significant changes in their needs, behaviour and circumstances.
- **16.** To take appropriate action in the event of unforeseen emergencies, ensuring that the Project Manager is informed promptly.
- 17. To follow Health and Safety guidelines carefully and to alert the Project Manager immediately of any concerns in relation to Health and Safety issues.
- **18.** To contribute to project records and individual case files.
- **19.** To carry out and record all financial transactions involving service users within agency guidelines.
- **20.** To carry out general administrative duties, housing management tasks and services as required.
- To contribute to service users' reviews, through the provision of verbal and written reports and by attending Support Planning meetings.

Additional Duties for Senior Support Worker:

- **22.** To offer informal and formal support and supervision to junior staff, relief staff, students and volunteers as appropriate, under the direction of the Registered Manager and Project Manager
- 23. To proactively identify meaningful daytime and leisure activities to promote personal development. To devise individual programmes of activity which meet the needs and preferences of service users.
- **24.** To communicate and liaise with colleagues and staff from partner agencies to ensure that consistent team working is maintained at all times.
- **25.** To plan ahead to meet the needs of service users as identified by their individual Person Centred Plan by:
 - Co-ordinating and deploying staff time in such a way as to ensure that service users needs are met and all agreed activities are carried out
 - Delegating tasks and responsibilities as appropriate

- Ensuring that all duties are carried out as prescribed and that quality standards are met at all times
- 26. To devise duty rota's in accordance with agreed staffing requirements and the needs of service users. To be pro-active and resourceful in addressing any gaps in service provision. To inform senior colleagues of the need for additional resources when required.
- 27. To ensure that all record keeping, general administration, housing management functions and services are carried out efficiently and to a high standard and to take responsibility for key tasks in these areas.
- **28.** To respond positively and quickly to any complaints or feedback from residents, relatives or other agencies.
- **29.** To take particular responsibility for aspects of health and safety
- **30.** To complete PMBPRO training including both understanding both Breakaway and Physical Intervention techniques and to renew this training as and when required.

Other:

- **31.** To notify Line Manager of planned whereabouts and to submit accurate timesheets
- **32.** To provide regular verbal and written reports to colleagues.
- **33.** To accept support, supervision and guidance from senior colleagues.
- **34.** To carry out all work in a manner consistent with the aims of the project and the service principles adopted by Creative Support.
- **35.** To comply with and to implement the Equal Opportunities Policy.
- **36.** To maintain confidentiality at all times, in accordance with the agreed policy.
- **37.** To undertake specific specialised training identified to enhance on teams expertise of working with people with learning disabilities, mental health needs and autistic spectrum disorders.
- **38.** To identify training needs in discussion with Line Manager and to attend training events and courses as required.
- **39.** To observe any written policies, procedures and guidelines for good practice agreed by Creative Support.
- **40.** To take on the role of shift co-ordinator when required.
- **41.** Any other duties as required.

Please Note: Our pay date is the 15th of each month (or the Friday before if this falls on a Saturday or Sunday). You will be paid in arrears for the previous 4/5 weeks, dependent on your starting date within the month. Starting pay points are allocated upon commencing the role based on criteria inclusive of experience, current specialism, salary and qualifications.

Hours of Work:

Full time hours are 37.5 per week. Hours to be worked flexibly on a rota which will include evenings, waking nights, weekends and bank holidays according to the needs of the service.

Bank Holidays:

An enhancement is paid for working at Christmas and New Year. We do not pay enhancements for working evenings, weekends or any other public holiday.

Care Certificate and Level 2/3 Health & Social Care Diploma:

All employees will be required to undertake and complete the Care Certificate. Following the successful completion of the probationary period staff are automatically enrolled onto Level 3 Health and Social Care Diploma. If you hold NVQ/Diploma 2/3 Health and social care or equivalent you will of course not need to do the award again, but we may support you to undertake qualifications.

Holidays:

20 days plus 8 statutory days pro rata.

Part Time Work:

Please note that annual leave and other entitlements are calculated on a pro-rata basis for employees working less than 37.5 hours. We take a positive view of part-time work and will consider reasonable requests for part time hours for a minimum of 15 hours per week.

Birthday Holiday Bonus:

You will be permanently entitled to one additional day (pro rata for part time employees) annual leave to be taken three weeks either side of your birth date. If you do not take this additional day within that period you will lose this entitlement for that year. Staff who are on maternity, paternity, adoption and sick leave at the time of their birthday will be entitled to take this additional leave upon their return to work.

Disclosure Checks:

All appointments will be subject to DBS enhanced disclosure and ISA checks.

Probationary Period:

The first four months will constitute a probationary period. When this is successfully completed, employment will be confirmed.

Probationary Bonus:

After the probationary period has been satisfactorily completed your further employment will be confirmed. Upon successful completion of your probationary period you will be entitled to a one off £100 bonus pro rata (subject to tax), providing all induction processes have been completed satisfactorily and upon completion and submission of you end of probationary review paperwork.

Sickness Policy:

Creative Support operates a discretionary company sick pay benefit scheme which is for the purposes of preventing hardship during times of serious illness. The eligibility criteria and conditions for payment of Company Sick Pay (inclusive of SSP) are shown in the Employee Handbook. You may be eligible for Company Sick Pay benefits subject to compliance with these criteria as follows:-

- Creative Support do not pay for the first three days of any sickness absence.
- First twelve months service Not eligible for Company Sick Pay though you may be entitled to SSP.
- Twelve months to twenty four months service Up to a maximum of four weeks at full pay.
- Twenty four months plus service Up to a maximum of eight weeks at full pay followed by four weeks at half pay.

Pension:

Creative Support operates an auto-enrolment pension scheme with the People's Pension.

Life Assurance:

Currently set at two time's basic annual salary. Staff become members of a non-contributory group life assurance scheme after 6 month employment. This scheme provides a death in service benefit of two time's annual salary. Participation in this scheme is subject to the rules of the scheme as amended from time to time. We reserve the right to discontinue, vary or amend its life assurance scheme at any time on reasonable notice to you.

Discretionary Benefits:

Creative Support offers discretionary benefits in addition to statutory benefits. These include:
