The Role:

To provide individualised person-centred support for service users at Ulverston Autism and Learning Disability Service. To enable users of the service to enjoy a fulfilled and valued life including having options to be involved in a variety of meaningful activities. Where we offer support people to make choices about their lives. To ensure that individuals are able to participate in the community which they are part of and develop their abilities as fully as possible.

Main Duties:

- 1. To develop and sustain warm and trusting relationships with service users.
- **2.** To promote the self-esteem, happiness and emotional health of service users.
- **3.** To respect the client's right to privacy and to ensure that their dignity is maintained at all times.
- **4.** To encourage and support service users in expressing their needs, views and concerns. To enable service users make choices and decisions and to participate as fully as possible in planning and decision-making processes.

Starting pay points are allocated upon commencing the role based on criteria inclusive of experience, current specialism, salary and qualifications.

Bank Holidays:

An enhancement is paid for working at Christmas and New Year. We do not pay enhancements for working evenings, weekends or any other public holiday.

Holidays:

20 days plus 8 statutory days pro rata.

Level 2 and/or Level 3 Health & Social Care Diploma/Learning Disability Certificate:

All employees will be required to undertake and complete the Level 2/3 Health and Social Care Diploma on the Learning Disability Pathway, or if the employee already has an NVQ but no Learning Disability qualification, they will need to complete the Level 2/3 Certificate in Learning Disabilities (applicable to Support Workers working in learning disability services only) as a condition of their employment. If you hold NVQ 2/3 health and social care or equivalent you will of course not need to do the award again, but we may support you to undertake qualifications

Hours of Work:

Full or part time. Full time is 37.5 hours per week, part time to be agreed subject to minimum 15 hours per week. To be worked flexibly on a rota which will include evenings, weekends and public holidays according to the needs of the service.

Birthday Holiday Bonus:

All employees are entitled to one additional day (pro rata for part time employees) annual leave to be taken two weeks either side of your birth date.
