## **JOB DESCRIPTION – SENIOR SUPPORT WORKER**

### **Chorley Outreach Service**

**Hours:** Up to 37.5 hours per week, to be worked flexibly to include evenings and weekends, according to the needs of the service.

**Responsible To:** Registered Manager/Operations Manager, Team Leader

#### **The Service:**

Townley House is a service that houses 6 service users with learning disabilities and mental health needs. In addition to this, there are service users on our outreach service, living in their own homes, requiring support with medication and community access.

#### **The Role:**

1. To provide individualised person-centred support to people with learning disabilities and mental health needs, living both in the service and in their own homes; to enable them to enjoy a fulfilling and valued life, to participate in the community and to develop their abilities as fully as possible.
2. To ensure that the service provided is responsive to the needs and preferences of service users and their families. To ensure that all contractual and regulatory requirements are met in full and that national minimum standards are exceeded.
3. To work collaboratively as part of a multi disciplinary team approach to meeting the needs of people residing at the service.
4. To provide mentorship; support; guidance for the staff team working within the service.
5. To ensure that all service users receive high quality, individualised, person-centred support which enables them to enjoy a fulfilling and valued life, to participate in the community and to develop their abilities as fully as possible.
6. To support the Team Leader with staff supervisions, uploading files and audits, organising shift cover and completing rotas if required.
7. To manage the team in the absence of the Team Leader.

#### **Main Duties:**

1. To develop and sustain warm and trusting relationships with service users.
2. To promote the self-esteem, happiness and emotional health of service users.
3. To respect the person's right to privacy and to ensure that their dignity is maintained at all times.

4. To encourage and support service users in expressing their needs, views and concerns. To enable service users to make choices and decisions and to participate as fully as possible in planning and decision-making processes.
5. To respect and promote the rights and entitlements of people with learning disabilities and mental health needs, and to enable them to participate as fully as possible in their communities.
6. To be responsive to the individual needs of service users within the framework of their Person-Centred Plans and to respond flexibly to changing needs.
7. To enable service users to become as independent as possible and to grow in confidence, competence and personal effectiveness in the following areas:
  - Social skills/relationships
  - Personal care & hygiene
  - Daily living skills
  - Using community resources and facilities
  - Social, leisure and work activities
  - Self-organisation and coping abilities
  - Personal safety
8. To achieve this through the provision of practical assistance, support, teaching, advice, role modelling, encouragement and positive feedback.
9. To monitor, review and evaluate individual protocols for people with complex needs in line with the person-centred plan.
10. To ensure that service users receive all necessary advice, care and regular health checks to ensure their physical health and well-being.
11. To promote nutrition, relaxation, exercise and a healthy lifestyle.
12. To support service users in developing a socially valued lifestyle which includes a varied range of culturally and age-appropriate experiences, building on the strengths, interests and aspirations of the service user. To enable people to access social, leisure, work and educational opportunities.
13. To enable service users to access developmental opportunities, new experiences and challenges, whilst not being exposed to unacceptable risks.
14. To assist service users in the administration and monitoring of prescribed medication in accordance with the Scheme's Medication Policy.
15. To observe and monitor the service users' emotional and physical well-being and to inform relevant staff and agencies of any concerns or significant changes in their needs, behaviour and circumstances.

16. To take appropriate action in the event of unforeseen emergencies, ensuring that the Line manager is informed promptly.
17. To follow Health and Safety guidelines carefully and to alert the Line manager immediately of any concerns in relation to Health and Safety issues.
18. To contribute to project records and individual case files.
19. To carry out and record all financial transactions involving service users within agency guidelines.
20. To carry out general administrative duties, housing management tasks and services as required.
21. To contribute to service users' reviews, through the provision of verbal and written reports and by attending Support Planning meetings.
22. To take particular responsibility for aspects of health and safety

**Other:**

1. To notify Line Manager of planned whereabouts and to submit accurate timesheets weekly.
2. To provide regular verbal and written reports to colleagues.
3. To accept support, supervision and guidance from senior colleagues.
4. To carry out all work in a manner consistent with the aims of the project and the service principles adopted by Creative Support.
