JOB DESCRIPTION – SUPPORT WORKER

Carlisle Complex Needs Service

Hours: 37.5 hours per week or part time, to be worked flexibly to include evenings, weekends and sleep in shifts, according to the needs of the service.

Responsible to: UBM and Area Manager Cumbria

The Role:

To provide individualised person centred support for people with learning disabilities, severe complex needs, autism, forensic and Mental Health enabling them to enjoy a fulfilling and valued life, to participate in the community and to develop their abilities as fully as possible.

Main Duties

1. To develop and sustain warm and trusting relationships with service users.
2. To promote the self-esteem, happiness and emotional health of service users.
3. To offer unconditional positive regard to service users, to respect right to privacy and to ensure that their dignity is maintained at all times.
4. To encourage and support service users to express their needs, views and concerns. To enable service users make choices and decisions and to participate as fully as possible in planning and decision-making processes. To enable people to contribute actively to decisions regarding their own care, support and activities through verbal and non-verbal communication methods which are tailored to their individual needs
5. To respect and promote the rights and entitlements of people learning disabilities, complex needs, autism and mental health to enable them to participate as fully as possible in their communities and to maintain community connections.
6. To carry out the role of key worker and to enable service users to achieve their goals and dreams by working alongside them to develop and implement within their person centred plans. To be responsive to changing needs and preferences.
7. To support service users in maintaining the safety, security, cleanliness and comfort of their homes. To support service users in understanding and adhering to the terms and conditions of their tenancy agreement and in enjoying the rights and responsibilities of being a tenant.
8. To enable service users to become as independent as possible and to grow in confidence, competence and personal effectiveness in the following areas:
 - Social skills/relationships
 - Personal care & hygiene
 - Daily living skills
 - Managing money
 - Using community resources and facilities
 - Social, leisure and work activities
 - Self organisation and coping abilities
 - Personal safety

To achieve this through the provision of practical assistance, support, therapeutic recreation and education sessions, teaching, advice, role modelling, encouragement and positive feedback.

9. To support service users in claiming their full benefit entitlement, budgeting and managing their personal finances as independently as possible to support their chosen lifestyle.
10. To provide respectful personal care in accordance with the needs, wishes and preferred routines outlined in the individual's personal support plans
11. To support people to enjoy a wide range of activities within the home and community which meets their needs. To support service users in developing a socially valued lifestyle which includes a varied range of culturally and age appropriate experiences, building on the strengths, interests and aspirations of the service user. To enable people to access social, leisure, work and educational opportunities.
12. To provide respectful personal care in accordance with the needs, wishes and preferred routines outlined in the individual's personal support plans. Some individuals will require support with their physical/mobility disabilities and may require support in wheelchairs, using hoists and other appropriate equipment to meet personal needs if required.
13. To ensure that service users receive all necessary advice, care and regular health checks to ensure their physical health and well being. To promote nutrition, relaxation, exercise and a healthy lifestyle. To observe and monitor the service users' emotional and physical well being and to inform the Senior Manager, families and other agencies of any concerns or significant changes in their needs, behaviour and circumstances.
14. To offer positive behaviour support to individuals who express their frustrations and needs through challenging behaviour by using appropriate strategies, management protocols and guidelines agreed with the multi-disciplinary team.
15. To work closely with the families of service users and other professionals involved in their care and support to provide coordinated services to meet the needs of the individuals. To encourage and support connections with families and friends. To positively and respectfully communicate with families and other professionals at all times.
16. To follow the guidance and risk management strategies outlined in the individual's risk management plan. To work in a safe and responsible manner to safeguard vulnerable service users from harm whilst ensuring they are able to make choices, enjoy new experiences and live a full life.
17. To ensure that vulnerable adults and children are safeguarded from harm. To comply with Creative Support and Council's safeguarding policy and procedures and to report any concerns regarding vulnerable adults or children with immediate effect to the Council, the Senior Manager and the Duty/On Call Manager.
18. To assist service users in the administration and monitoring of prescribed medication in accordance with the Service's Medication Policy.
19. To take appropriate action in the event of unforeseen incidents and emergencies, ensuring that the Senior Manager is informed promptly.

- 20. To follow health and safety guidelines carefully and to alert the Senior Manager immediately of any concerns in relation to Health and Safety issues.
- 21. To contribute to project records and individual case files.
- 22. To carry out and record all financial transactions involving service users within agency guidelines.
- 23. To carry out general administrative duties, housing management tasks and services as required.
- 24. To contribute to person centred reviews, through the provision of verbal and written reports and by attending Support Planning meetings.
- 25. All employees should be aware that due to the nature of work Creative Support undertakes there is a requirement to support service users with daily living skills & individual activities which include moving & handling and may involve supporting people with personal care needs.

Other

- 26. To notify Line Manager of planned whereabouts and to submit accurate timesheets weekly.
- 27. To provide regular verbal and written reports to colleagues.
- 28. To accept support, supervision and guidance from senior colleagues.
- 29. To carry out all work in a manner consistent with the aims of the project and the service principles adopted by Creative Support.
- 30. To comply with and to implement the Equal Opportunities Policy.
- 31. To maintain confidentiality at all times, in accordance with the agreed policy.
- 32. To identify training needs in discussion with Line Manager and to attend training events and courses as required.
- 33. To observe any written policies, procedures and guidelines for good practice agreed by Creative Support.
- 34. To take on the role of shift co-ordinator.
- 35. In accordance with the Health and Social Care Act 2008, to actively participate in the prevention and control of infection within the capacity of the role.
- 36. Any other duties as required.

Please Note: <i>Our pay date is the 15th of each month (or the Friday before if this falls on a Saturday or Sunday). You will be paid in arrears for the previous 4/5 weeks, dependent on your starting date within the month.</i>	

Hours of Work:

Full or Part Time. Full time hours are subjected to 37.5 hours per week. To be worked flexibly on a rota which will include evenings, nights, weekends and public holidays according to the needs of the service. Part time hours to be agreed subject to a minimum of 15 hours per week.

Sleep Ins:

Where there is a requirement for staff to sleep-over on the premises a sleep-over payment is made for each shift. The payment for each sleep-over undertaken but may vary according to the needs of the service.

Bank Holidays:

An enhancement is paid for working at Christmas and New Year. We do not pay enhancements for working evenings, weekends or any other public holiday.

Holidays:

20 days plus 8 statutory days pro rata.

Birthday Holiday Bonus:

All employees are entitled to one additional day (pro rata for part time employees) annual leave to be taken two weeks either side of your birth date. If you do not take this additional day within that period you will lose this entitlement for that year. Staff who are on maternity, paternity, adoption and sick leave at the time of their birthday will be entitled to take this additional leave upon their return to work.

Disclosure Checks:

All appointments will be subject to DBS enhanced disclosure and ISA checks.

Probationary Period:

The first four months will constitute a probationary period. When this is successfully completed, employment will be confirmed.

Probationary Bonus:

After the probationary period has been satisfactorily completed your further employment will be confirmed. Upon successful completion of your probationary period you will be entitled to a one off £100 bonus pro rata (subject to tax), providing all induction processes have been completed satisfactorily and upon completion and submission of you end of probationary review paperwork.

Sickness Policy:

Creative Support operates a discretionary company sick pay benefit scheme which is for the purposes of preventing hardship during times of serious illness. The eligibility criteria and conditions for payment of Company Sick Pay (inclusive of SSP) are shown in the Employee Handbook. You may be eligible for Company Sick Pay benefits subject to compliance with these criteria as follows:-

- Creative Support pays SSP for the first three working days of any sickness absence
- First twelve months service - Not eligible for Company Sick Pay though you may be entitled to SSP.
- Twelve months to twenty four months service - Up to a maximum of four weeks at full pay.
- Twenty four months plus service - Up to a maximum of eight weeks at full pay followed by four weeks at half pay.

Pension:

Creative Support operates an auto-enrolment pension scheme with the People’s Pension.

Life Assurance:

Currently set at two times basic annual salary. Staff become members of a non-contributory group life assurance scheme after 6 month employment. This scheme provides a death in service benefit of two times annual salary. Participation in this scheme is subject to the rules of the scheme as amended from time to time. We reserve the right to discontinue, vary or amend its life assurance scheme at any time on reasonable notice to you.

Discretionary Benefits:

Creative Support offers discretionary benefits in addition to statutory benefits. These include:

- Paid paternity leave

- Carer’s leave up to 5 days per annum
