## **JOB DESCRIPTION – SENIOR SUPPORT WORKER**

### **Wakefield Supported Living Services**

**Hours:** Full time hours, 37.5 hours per week. (Flexible: to include days, evenings, nights, weekends and public holidays according to the needs of the service).

**Responsible to:** Registered Manager/ Deputy Manager.

#### **The Role:**

- To provide individualised person centred support to people with learning disabilities living in their own homes; to enable them to enjoy a fulfilling and valued life, to participate in the community and to develop their abilities as fully as possible.
- To ensure that the service provided is responsive to the needs and preferences of service users and their families.
- To ensure that all contractual and regulatory requirements are met in full and that national minimum standards are exceeded.
- To work collaboratively as part of a multi-disciplinary team approach to meeting the needs of people residing at the service.
- To provide mentorship; support; guidance for the staff team working within the service.
- To ensure that all service users receive high quality, individualised, person centred support which enables them to enjoy a fulfilling and valued life, to participate in the community and to develop their abilities as fully as possible.

#### **Main Duties:**

- 1.1** To develop and sustain warm and trusting relationships with service users.
- 1.2** To promote the self-esteem, happiness and emotional health of service users.
- 1.3** To respect the person's right to privacy and to ensure that their dignity is maintained at all times.
- 1.4** To encourage and support service users in expressing their needs, views and concerns. To enable service users to make choices and decisions and to participate as fully as possible in planning and decision-making processes.
- 1.5** To respect and promote the rights and entitlements of people with learning disabilities, and to enable them to participate as fully as possible in their communities.
- 1.6** To be responsive to the individual needs of service users within the framework of their Person Centred Plans and to respond flexibly to changing needs.
- 1.7** To enable service users to become as independent as possible and to grow in confidence, competence and personal effectiveness in the following areas:
  - Social skills/relationships
  - Personal care & hygiene
  - Daily living skills
  - Using community resources and facilities

- Social, leisure and work activities
- Self-organisation and coping abilities
- Personal safety

To achieve this through the provision of practical assistance, support, teaching, advice, role modelling, encouragement and positive feedback.

- 1.8** To support people who express their frustrations and needs through challenging behaviour by using appropriate strategies and intervention frameworks as specified by the Person Centred Plan.
- 1.9** To monitor, review and evaluate individual protocols for people with complex needs in line with the person centred plan.
- 1.10** To ensure that service users receive all necessary advice, care and regular health checks to ensure their physical health and well-being.
- 1.11** To promote nutrition, relaxation, exercise and a healthy lifestyle.
- 1.12** To support service users in developing a socially valued lifestyle which includes a varied range of culturally and age appropriate experiences, building on the strengths, interests and aspirations of the service user.
- 1.13** To enable people to access social, leisure, work and educational opportunities.
- 1.14** To enable service users to access developmental opportunities, new experiences and challenges, whilst not being exposed to unnecessary risks.
- 1.15** To assist service users in the administration and monitoring of prescribed medication in accordance with the Service's Medication Policy.
- 1.16** To observe and monitor the service users' emotional and physical well-being and to inform relevant staff and agencies of any concerns or significant changes in their needs, behaviour and circumstances.
- 1.17** Conduct support planning reviews and risk assessments in relation to both service users and their home environment, when needed particularly when there has been a significant change in circumstances and in the likeliness of risks/needs.
- 1.18** Offer support, supervision and guidance to all staff, ensure that staff are appropriately supported, trained and understand the needs of each service user they support in line with support plans.
- 1.19** Liaise with team members to ensure a consistent and coordinated service.
- 1.20** Assist senior managers with running of the service, ensuring that new staff are welcomed and fully informed of their rights and responsibilities to ensure a high quality service. Ensure that the service fulfils CQC care standards at all times.

- 1.21** Develop warm, trusting relationships with service users and families and encourage them to express their needs, views and concerns.
- 1.22** Work alongside the Service Manager and Deputy Manager and take delegated responsibility for:
- Health and Safety
  - Feedback and report writing
  - Monitoring quality of the service
  - Completing rotas
  - Service User opportunity and participation
  - Financial and administrative procedures
  - Medication procedures
  - Lone working policies and procedures
  - Complaints, compliments and suggestions procedures
  - Identifying training needs for staff
  - To liaise with the management team regarding any annual leave the staff team wish to take
  - Safeguarding procedures
- 1.23** Assist in monitoring service user's health and wellbeing and inform the Registered Manager and involved professionals of changes in needs concerns or circumstances. Liaise with GP's, district nurses, occupational therapists and involved professionals to meet service user needs.
- 1.24** Respect the service user's right to privacy and to ensure that their dignity is maintained at all times.
- 1.25** Enable service users to retain as much independence and control over their lives as possible. Enhance the confidence and coping abilities of service users through encouragement and positive feedback.
- 1.26** Promote service user's self-esteem and enable them to express preferences and make choices and decisions.
- 1.27** Support service users in meeting their cultural and spiritual needs and in expressing their personal identity and chosen lifestyle.
- 1.28** Support and enable service users to participate in their communities and to enjoy activities in the community. Encourage social and leisure activities and the maintenance of social networks.
- 1.29** Support service users in taking prescribed medication. Complete a robust medication risk assessment. Record medication taken on the Medication Recording Sheet. Encourage service users to manage their medication as independently as possible.
- 1.30** Work within agreed risk management guidelines and assist service users in reducing risks to themselves or others. Promptly report concerns regarding risks to the Registered Manager.

- 1.31** Maintain a high standard of customer care and encourage feedback from service users, families and involved professionals. Document complaints, suggestions and feedback and report these to the Registered Manager.
- 1.32** Take appropriate action in the event of unforeseen emergencies, ensuring that the Registered Manager is promptly informed.
- 1.33** Follow health and safety guidelines and alert the Registered Manager of health and safety concerns.
- 1.34** Ensure that records are accurate, up-to-date and in the prescribed format. Document work undertaken in support of service users, their progress, concerns and communication with families and other agencies.
- 1.35** Ensure that financial transactions are promptly and accurately recorded in line with Creative Support procedures.
- 1.36** Contribute to service user reviews through verbal and written reports and by attending review meetings.
- 1.37** Provide respectful personal care following needs, wishes and preferred routines outlined in personal support plans. Some individuals require support with physical/mobility disabilities and may require support in wheelchairs, using hoists and other appropriate equipment to meet personal needs.

**General Duties:**

- 1.38** Undertake the role of On Call a rotational basis for the service.
- 1.39** Notify Line Manager of planned whereabouts and to submit accurate timesheets weekly.
- 1.40** Accept support, supervision and guidance from senior colleagues.
- 1.41** Undertake specific specialised training for working with people with learning disabilities as needed.
- 1.42** Identify training needs with Line Manager and attend training events and courses as required.
- 1.43** Ensure that you and other staff, volunteers and students on placement comply with the following:
  - Health and Safety policies and Equal Opportunities Policy
  - Safeguarding of Vulnerable Adults, including immediate reporting of safeguarding concerns to the Council, the Registered Manager and the Duty/On Call Manager
  - Confidentiality and data protection
  - Health and Social Care Act 2008, including active prevention and control of infection within the capacity of the role
  - All Creative Support policies, procedures and guidelines for best practice

<b>Please Note:</b> <i>Our pay date is the 15th of each month (or the Friday before if this falls on a Saturday or Sunday). You will be paid in arrears for the previous 4/5 weeks, dependent on your starting date within the month. Starting pay points are allocated upon commencing the role based on criteria inclusive of experience, current specialism, salary and qualifications.</i>		

#### Hours of Work:

Full time, 37.5 hours per week. To be worked flexibly on a rota which will include days, evenings, weekends and public holidays according to the needs of the service. On call payments will be made in addition to your salary.

#### Holidays:

20 days plus 8 statutory days pro rata.

#### Bank Holidays:

An enhancement is paid for working at Christmas and New Year. We do not pay enhancements for working evenings, weekends or any other public holiday.

#### Level 2 and/or Level 3 Health & Social Care Diploma:

All employees will be required to undertake and complete the Level 2 and/or Level 3 Health and Social Care Diploma, as a condition of their employment if you already hold NVQ 2 health and social care or equivalent qualification you will not need to do the award again, but we may support you to undertake a level 3 or other relevant qualification at our cost.

#### Birthday Holiday Bonus:

All employees are entitled to one additional day (pro rata for part time employees) annual leave to be taken two weeks either side of your birth date. If you do not take this additional day within that period you will lose this entitlement for that year. Staff who are on maternity, paternity, adoption and sick leave at the time of their birthday will be entitled to take this additional leave upon their return to work.

#### Disclosure Checks:

All appointments will be subject to DBS enhanced disclosure and ISA checks.

#### Probationary Period:

The first four months will constitute a probationary period. When this is successfully completed, employment will be confirmed.

#### Probationary Bonus:

After the probationary period has been satisfactorily completed your further employment will be confirmed. Upon successful completion of your probationary period you will be entitled to a one off

£100 bonus pro rata (subject to tax), providing all induction processes have been completed satisfactorily and upon completion and submission of you end of probationary review paperwork.

#### **Sickness Policy:**

Creative Support operates a discretionary company sick pay benefit scheme which is for the purposes of preventing hardship during times of serious illness. The eligibility criteria and conditions for payment of Company Sick Pay (inclusive of SSP) are shown in the Employee Handbook. You may be eligible for Company Sick Pay benefits subject to compliance with these criteria as follows:-

- Creative Support pay for the first three days of **any** sickness absence.
- First twelve months service - Not eligible for Company Sick Pay though you may be entitled to SSP.
- Twelve months to twenty four months service - Up to a maximum of four weeks at full pay.
- Twenty four months plus service - Up to a maximum of eight weeks at full pay followed by four weeks at half pay

#### **Pension:**

Creative Support operates an auto-enrolment pension scheme with the People's Pension.

#### **Life Assurance:**

Currently set at two times basic annual salary. Staff become members of a non-contributory group life assurance scheme after 6 months of employment. This scheme provides a death in service benefit of two times annual salary. Participation in this scheme is subject to the rules of the scheme as amended from time to time. We reserve the right to discontinue, vary or amend the life assurance scheme at any time on reasonable notice to you.

#### **Discretionary Benefits:**

Creative Support offers discretionary benefits in addition to statutory benefits. These include:

#### **Employee Assistance Service:**
